



# GOVERNANCE



The International Emissions Trading Association (IETA) emerged from the [United Nations Conference on Trade And Development \(UNCTAD\)](#) Policy Forums on greenhouse gas emissions trading in 1999. It started as a result of cooperation between UNCTAD and the [World Business Council for Sustainable Development \(WBCSD\)](#).

IETA received legal non-profit status from the government of Switzerland in June 2000, and received [United Nations Framework Convention on Climate Change \(UNFCCC\)](#) non-governmental organisation accreditation in October 2000.

IETA is a membership organisation where all members have one vote, used at the Annual General Meeting and any Extraordinary General meetings. Half of IETA's 18 Board members are elected each year.
