We now offer independently certified, responsibly produced aluminium from our smelters in Australia and New Zealand that predominantly use hydro-powered electricity. ASI has granted its Performance Standard and Chain of Custody certifications to our Amrun and Weipa bauxite mines, Yarwun alumina refinery, and the Bell Bay and NZAS aluminium smelters. This strengthens our ability to offer ASI aluminium throughout our global supply chain, building on the certifications in place for our Canadian operations.

ASI certification means customers can be assured that the aluminium they purchase has been produced with high environmental, social and governance standards, ranging from greenhouse gas emissions to human rights. This certification expands our offering of independently certified, responsibly produced aluminium to customers around the world. It continues our leadership on responsible aluminium production from mine to market, so that our customers can meet growing consumer demand for sustainably sourced materials.

In 2019, we participated through various industry associations on consultations regarding the federal proposed Clean Fuel Standard, and worked with sub-national governments both directly and through our associations to refine the design details of the carbon pricing systems which came into force in most jurisdictions in 2019. We provided submission paper mostly through industry associations (Mining Association of Canada, Business Council of British-Colombia, Conseil Patronal Environmental du Canada, and Aluminium Association of Canada). We also engaged with Provincial/territorial governments on the development or modifications of their own carbon pricing system (Northwest Territories, Newfoundland and Labrador, Alberta). In Quebec, Rio Tinto has participated in preliminary consultations through meetings and submission papers to define the 2024-2030 targets for free allowances. In Alberta, the new government elected has cancelled the carbon tax and we participated in consultations that saw the output based system applied to large emitters by January 2020. In Europe, due to an important reduction of our footprint, we engage mostly through the industry associations (European Aluminum Association and Eurometals). In New Zealand, we engaged with the New Zealand Government and the Ministry for the Environment during 2019 on the Draft Net Zero Bill for New Zealand.

in any of the backstop jurisdictions where the federal Output Based Pricing System applies, and we did not therefore intervene other than saying that we are supportive on putting a price on carbon and to implement market mechanisms. For the Low Carbon Fuel regulation, we are worried that the same carbon dioxide emissions could be taxed twice, and that there needs to be recognition in the regulation of circumstances in northern regions where there is no clean fuel alternative such as electricity. Our northern operations could be significantly impacted as a result. We did make representations multiple times on this topic. In Quebec, Rio Tinto is supporting the market mechanism in place as an effective tool to drive emission reduction but argued that a drastic versus a more gradual reduction in free allowances could undermine the profitability of some sites when compared to competitors operating in high emitting jurisdictions without supporting the desired outcome of global emission reduction. Carbon tax

Support with major exceptions

We engage with the South African National Treasury on its proposals for a carbon tax in South Africa, both bilaterally and through industry associations. This includes responding to published consultation documents. In Canada, Rio Tinto engages on the tax regime in British Columbia. In 2019, we engaged directly with the government and through the Business Council of British Columbia on the province's benchmarking study, to determine how BC industry's measure against peers around the world. This was part of a broader Clean Growth Strategy for the province.

Significant modifications to the South African carbon tax have been proposed to help protect competitiveness and avoid leakage, enhancing its environmental effectiveness. In 2019, Rio Tinto played a key role in BC to facilitate a technical and data driven discussion between the BC government and the business community resulting a fair and reasonable international benchmarking exercise. In addition Rio Tinto successfully built support for the recognition and protection for energy intensive trade exposed sector like aluminium manufacturing. This work also encouraged the BC government to better understand the cost of a high regulatory burden and how a regulatory framework can be established to protect the environment and stimulate the economy.

Rio Tinto outlined support for a national approach to delivering on Australia's international commitments and welcomed a continued approach by the Western Australian Government of working to deliver state based policy that is integrated into a national framework. We described abatement opportunities of particular relevance to our West Australian operations including the implementation of a portion of renewable energy into our electricity generation and the longer term work across the global business considering the transitioning of the mobile mining fleet from diesel to lowemission energy. The ETC is tackling the challenge of how we reduce emissions from the "hard-to abate" industrial and transport sectors of the economy, including steel – the customer for our iron ore and the source of most of our scope 3 emissions. We are also working together to establish effective market-based trading systems for greenhouse gas (GHG) emissions and removals that are environmentally robust, fair, open, efficient, accountable and consistent across national boundaries. A Rio Tinto representative is currently chairman of the board of IETA, as well as co-chair of the international working group.

Positions taken by industry associations on a given topic will consider a range of members' views, and the nuance and emphasis of an industry association's position may differ from that of Rio Tinto. We believe that diverse and differing views should be heard and are an important step in finding compromise that allows progress to be made. Recognising that an industry association's view will not always be the same as ours, we review the value of individual industry association memberships both prior to joining and when membership is due for renewal. We have published principles which govern our approach to participation in industry associations.

We provide additional information on industry association memberships, listing the top five industry groups we engage with by membership fees and the industry groups we have engaged on climate policy issues. This includes detail on where industry association positions on climate change significantly differ from that of Rio Tinto's.

In April 2019 we issued stronger quidance for our industry associations regarding our expectations in relation to climate change and energy policy advocacy. Our Industry Associations and Climate Change statement outlines that where our membership is significant, we will work in partnership with those industry associations to ensure that their advocacy is consistent with our own public position and the Paris Agreement. Furthermore, that we will consider our support and membership where they do not partner with us in seeking to advance the policy agenda consistent with the outlined principles, once we have engaged in a formal dialogue process with them.

In reviewing 2019 activities, we have become aware that some of our industry association and climate change principles leave room for interpretation and therefore require clarification, which we will action in due course.
